1-YEAR LIMITED WARRANTY FOR STAND ALONE LED DRIVERS

ConTech Lighting warrants to its customer and the original end user that stand alone LED drivers will be free from manufacturing defects for a period of one (1) year from the date of shipment by ConTech Lighting. This warranty does not cover LED drivers sold as part of a light fixture.

ConTech Lighting, at its sole option, will repair, replace, credit or refund, any product returned to it within the warranty period that it determines to be defective. Customer or consumer must return the product, transportation prepaid, to ConTech Lighting at 725 Landwehr Road, Northbrook, IL 60062 within the warranty period. No return of products will be accepted without a Return Goods Authorization ("RGA") which may be obtained by calling 847-559-5550. This warranty excludes and there is disclaimed liability for labor for removal or reinstallation of this product or a replacement product. This warranty is void if this product is installed in violation of the National Electrical Code, or any applicable local electrical codes, or in an improper environment, misused, opened, abused or altered in any manner, or is not used under normal operating conditions, or not in accordance with any labels or instructions. This warranty does not cover damages due to environmental conditions, acts of nature, animal or insect activity, or power surges.
